**MESSAGE:** Mr. Lambros asked me to ask you by fax to confirm from your contacts the Brazilian Extradition Numbers and the U.S. Extradition Proceeding Numbers of the following two individuals who were incarcerated with Mr. Lambros at the Police Holding Facility in Brazilia (the U.S. government has changed their names):

*June 2, 1993 ORREN called B.O.P. & they stated they did not have ANDREACI in the computer*

1. Louis Carlos Andreaci Mr. Andreaci is a former Varig employee, born in Brazil with Sao Paulo contacts, possibly in the publishing business. Mr. Andreaci is a U.S. citizen, and his family currently lives in Florida.

2. Aly Ayoub (a/k/a Tony) Mr. Ayoub is a Canadian citizen of Arabic descent who was extradited to the U.S. on heroin charges shortly after John was. His extradition was confirmed by the Canadian embassy in Brazilia. Mr. Ayoub was arrested in Sao Paulo and transferred to Brazilia.

FYI, we can now confirm the placement of bio-medical implants in Brazilian jails, and the removal of same by U.S. authorities. Thank you or any background information you can obtain on these two individuals.
