On December 22, 1999, Judge Mason issued an ORDER as to expert witnesses and discovery. Upon reviewing documents within my possession I think it is important for me to disclose documents I've received from the following individuals:

Dr. Sutton has not made such a statement, but it is my thoughts that he will release all material to Senator Helms and the Senate anyway, thus it is appropriate for your review.

Dear Sir

We regret to inform you that our firm is incapable of obtaining the affidavits you are requesting. To begin with we have no resources to operate in Brazil. Secondly, we are not likely to be getting any cooperation in obtaining information from Mr. Cartwright or his ranger team because they are intelligence official. The cardinal rule for all intelligence officials is silence.

Mr. Lambros, you must approach your delima with a certain sense of realism. You must acknowledge that very little information {if any} will ever be made public regarding the "Brain Implant" phenomena by way of the freedom of information act. I doubt that any attorney will ever be able to force an intelligence officer from any branch of the community to admit that such devices exist, and are in use to this day.

May I suggest that you approach this subject from a purely academic point of view. Try to obtain the opinions of a few well known neurologists. Without mentioning the word "implant" or telling them your story, try to collect information about the subject: "Brain stimuli by way of electrical pulses". You will be searching for specific information regarding voltages, currents, waveform types, pulse durations, placement strategy, locality of placement for the electrodes, expected results, experimental results in primates, experimental results in humans, and any other purely scientific information regarding the placement of electrodes inside the human brain.

Now, Let me tell you about the results of my own research in Electromagnetic communications research. This subject has nothing to do with brain implants but as you will see, it could very well have been the roots for implant research. Back in the 1960s scientists in both England and Russia had been working on developing a clandestine method of sending electromagnetic waves to a receiver which had no parts or batteries in them. These devices were called "PARAMETRIC CAVITIES". physically they were simply shaped like small cylinders with thin gold diaphragms mounted in them. The theory of operation was based on a metallic substances of a specific shape having ability to interact with microwave frequencies in such a fashion as to oscillate in sympathy and generate a lower harmonic radio frequency which could then be received by a nearby receiver. This theory worked very well for clandestine eavesdropping equipment. The device needed no power source, looked completely innocuous, and could not be detected via traditional means.

It now occurs to me that the implants detected in the X-rays of your skull could very well be "Parametric Cavities". they certainly fit the shape description necessary for such devices to operate. Judging from the size of the devices in your case, it would take an extremely high frequency microwave beam to interact with them. Perhaps in the order of several hundred Gigahertz. Such equipment is highly complex and difficult to obtain. There are no practical applications other than space communications at these frequencies. It is possible however for these extremely high frequency microwave carriers to be modulated in either frequency or amplitude for the purpose of sending control signals of the same type and purpose as the electrode implants used for brain experiments by our modern day academia.


So there you have it, a combination of two purely academic sciences: A) Electrode Stimuli of the cerebral cortex, and B) Parametric Cavities as used in telemetric applications. Together they spell "Brain Control Implants". Now If I were to provide plenty more details on frequencies, shape, modulation types, beam width, radio field strength, aperture types, cerebral mapping, and several medical procedures, I would have created a document that some military types would probably end up stamping SECRET on it and you would never see it.

Too bad however, and I don't happen to work for any "Secret Agencies" any more, nor have I ever signed any secrecy agreements. So be it, and you have my permission to use this document for your defense. I also encourage you to follow through with contact to a neurologist who can confirm my suspicions that modulated parametric cavities can duplicate the control actions of electrode implants. If you can find someone who has a medical background who is willing to talk to me about it, I would surely be more interested in pursuing this theory myself.

All I ask is that you keep the media out of it. I do not want this document or any of my comments to end up in some political publication. I am interested in helping you but I am not going to step in the way of a Charging ELEPHANT to do it. To this end I am hereby notifying you that this correspondence is confidential and may not be used or quoted publicly without my expressed permission. You are permitted to use it for legal purposes and to elicit the assistance of any Scientific or Medical professional in determining the existence, origin and purpose of the devices found in your brain.

Good luck in your quest, and please don't give up. After all you're not the only person who is suffering from this phenomena, but perhaps you are the person who will help solve the mystery, and it may get you out of prison.

Dear Mr. Lambros

I'm sorry for the delay in answering your questions, I do not correspond very much with the public, because I am a science nut and I spend most of my time talking shop with other "egg heads". I have not received any correspondence regarding the subject of my last letter to you. I have found the following enclosed document describing an implant tracking device. As quoted in the patent, such a device is used to track the movement of "an object, animal or *human*". This proves beyond a shadow of doubt that such implants exist. The fact that certain advancements have made it possible for these types of devices to become electronically interactive, in other words, - that the devices can now receive signals and translate the signals into biological nerve stimuli, - is simply an indication that a slightly more advance technology was used in your case.



1. Your August 10 action on civil rights under extradition treaty is potentially fruitful. Even if the court turns you down this is a line to take. Appears to me there is specific evidence you were wrongly treated by State..how can an American citizen be illtreated and this ignored by State ? This is something for the Senate Foreign Relations Committee under Senator Jesse Helms.
2. Your need now is to get writers interested in your case. They all follow each other..I try to initiate rather than follow. October issue of PL will have extensive material on DOJJustice problems, Ive included you as an example. If you keep hammering away someone will pick up the threads.
3. Dont be too quick to reject those persons where you get an initial turn down. There are many reasons why they could come on board later. For example on Scientology. Wait until your case fits THEIR CRITERIA then re-approach them. Persistence!
4. The Akwei aspect is puzzling. You sent me several interesting pages from evidence in 1992 Akwei vs NSA law suit. The handwriting presumably is that of Akwei. I wrote to the US Courthouse carefully and have so far received a few pages of materials BUT THE HANDWRITING IS ENTIRELY DIFFERENT TO THE SHEETS YOU SENT ME. I am moving carefully (a few pages at a time) because I dont want to alert the clerk. I am working on the possibility that NSA got Sporkin to kill the case and then substituted other materials in the courthouse file (Keep this to yourself until I find out more). Where did you get your materials?

MEMORANDUM OPINION AND ORDER

Plaintiff has brought this action pro se, alleging that employees of the National Security Agency have engaged in harassment and criminal offenses directed toward him. He is seeking damages. Plaintiff claims the harassment began when certain individuals who are now employed by the NSA were students with him at Northwood High School in Wheaton, Maryland. He then describes a variety of instances of harassment, all of which appear to be frivolous. For example, he alleges that in December of 1981, he found a paragraph of "graphitti" on a bus shelter at the Silver Spring Metro station that "described the jacket I was wearing in detail, and contained a paragraph of threats and racial slurs directed at me personally." Complaint at 6. He also alleges that on December 24, 1991 there was an "attempted poisoning." His complaint includes a "List of Illegal Activities Committed," one of which is "continuous attempts to damage mental health since 1980."

The Court is unable to construe this complaint as stating

6. I don't need any recognition/credits or anything else. I'm happy to do what little I can because these Washington tin gods are way out of line. However at 70 my involvement is necessarily limited and I have pressures to keep quiet. ←
The most productive route is to take anything I write and circulate copies. Remember I am juggling 50 balls --- at a time when I want to retire!

7. Any electronics people in there? I'd like to know what frequency these people use for transmissions.

8. October P.L. will aim at Department of Justice and 25 cover ups including your case.

9. Have received the financial records in part on MK ULTRA from CIA. Will work through them looking for equipment purchases. ←
